Good evening, everybody. I would like to start off by just giving an update on our Continuity of Instruction Plan Phase II started today a copy of the plan was provided to all students and parents on Monday via the internet and all teachers have received copies of it. The expectations for the plan are going to help students to have more engagement with their classroom and to be introduced to new concepts and grade level skills and course curriculum than they had been doing in Phase 1. The administrative team continues to work on a daily basis with the teachers to make sure that we are providing the best distance learning opportunities that we can for the students. Our teachers are availing themselves of professional development opportunities on a regular basis to get themselves up to speed in areas where they may need a little bit more support and mechanisms are in place on our technology platforms so that teachers can see students and how often they're logging on whether they're logging on and how long they are engaged in the various platforms. The plan will be periodically reviewed with students and parents accordingly. I am going to give it till next Thursday unless I receive feedback from teachers from the administrative team from parents and from students. See where we are and if necessary, make any changes. Great suggestions have come in from students and from parents. So, we encourage those to keep coming because they are helping us when we have to make adjustments or modifications to the plans as required by the state. The approved Every Student Succeeds Act, the New York State Education Department posted the participation rate status report for all school districts. Manetuck, Oquenock and Beach Street were on the list with participation rates on the state tests in the bottom 10%. So, this is going to require that our building principals create a Participation Rate Improvement Plan that delineates how they plan to increase the participation for 2020-2021. The plan was originally due for submission to the New York State Education Department on May 1st, however due to current circumstances, the deadline has been extended. Parameters of the plan are going to be extended because some of the plan was for this year and obviously because the tests are not taking place that may change our parameters a little bit. The principals were provided with all the information that they need to complete the plans for each building and these plans will be submitted to the board of education for approval prior to sending it to the state. It should also be noted that the other two elementary schools Bayview and Paul J. Bellew as well as Udall Road were flagged as being in jeopardy for next year. We are going to be working really hard to engage our students in the assessment process and ensure that the instructional support and programs are sound and reviewed if warranted. At of this time, that is all that I have does anybody have any questions in regards to anything that's taking place?

Sure. Do we have a way to measure the engagement of the kids in the remote learning? Like are we getting half the kids 90% of the kids.

There are some in every school building that are being followed up on first by teachers and then support staff, social workers, building administration, school counselors, and those types of means.
