The Suffolk County Police Department has notified our district that a Low Risk – Level 1 sex offender is residing in the West Islip area. The information provided to us by the police is available upon request. You may obtain the information by visiting the district's website, www.wi.k12.ny.us or any West Islip school building.

When visiting your preferred location, you will be asked to provide your name, address and proof of identification. This is to ensure that the school district takes the utmost care in providing information only to parties with a vested interest. It is important to note that it is illegal to use this information to commit a crime against or to engage in illegal discrimination or harassment against this person.

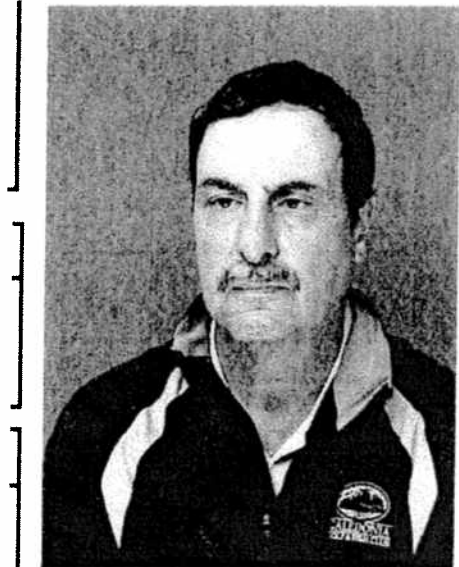
